FRAMEWORK AGREEMENT OF ACADEMIC COOPERATION has been made and entered into force by July 16th between:

INTERNATIONAL YOUTH COOPERATION (hereinafter referred to as "IYC"), with RSIN 857242039, association with full legal capacity registered with number 67956661 in the register of the Dutch Chamber of Commerce located in Heerendonklaan 21, 5223XS 's-Hertogenbosch (Holland), herein represented by Mr. Rafael Herraiz Solla on his capacity as authorized hereto; and the **EUROPEAN** INSTITUTE President duly, INTERNATIONAL STUDIES (hereinafter referred to as "EIIS"), with Swedish Tax number 802509-7372, having its office at Primusgatan 50, lgh 1902, 11267 Stockholm (Sweden), herein represented by Mario Torres Jarrín on his capacity as President/Director of the European Institute of International Studies, duly authorized hereto.

WHEREAS

1. EIIS is a center for research and education in international relations: diplomacy, global governance, sustainable development and economic growth. Our mission is to prepare leaders with a positive action to make difference in the building of a better world. EIIS offers its students an integral education with values and principles that will serve in their professional life, as well as to assume their social responsibilities.

EIIS has among its objectives to provide academic research and programs to serve key decision makers from the public and private sectors. It also offers an independent forum for dialogue among international organizations, foreign ministries and academic institutions, effectively supporting the development of mutually beneficial solutions for key issues.

- 2. IYC is an association currently composed by youth association from 12 European countries, are.
 - The organization of activities that aim to involve young people in improving the situation of those in need by doing voluntary work;
 - The organization of activities that aim to develop the talents and knowledge of young people in order to make them become a better person;
 - Promoting equal opportunities for young men and women;
 - The organization of activities aiming for the improvement of the quality of the work of young people;
 - Promoting international projects such as exchange programs and the promotion of volunteering in other countries, all as far as it helps the participants to achieve the goals listed under a. to d. above;

- Collecting funds to improve projects for the benefit of those who need it the most, especially children in developing countries.
- 3.. They agree that is the desire of both institutions to sign a *Framework Agreement of Coopoeration* in order to establish an adequate legal and institutional framework to promote training activities in matters of common interest.

For that purpose, they sign in this Framework Agreement of Coopoeration, which will be governed by the following

ARTICLES

FIRST: EIIS and IYC will promote cooperation between both of them in order to develop joint activities in the training area, as well as, training and social service activities aimed at young people. That the framework of this activities is set within the context of the European Youth Strategy 2019-27 with the following general objectives:

- enable young people to become the architects of their own lives, support their personal development and growth to autonomy, build their resilience and equip them with life skills to cope with a changing world;
- encourage and equip young people with the necessary resources to become active citizens, agents of solidarity and positive change inspired by the EU values and European identity;
- improve policy decision with regard to their impact on young people across all sector, notably employment, education, health and social inclusion;
- contribute in the eradication of youth poverty and all forms of discrimination and promote social inclusion of young people.

SECOND: Both institution will exchange the necessary information to determine the specific work areas in which there is interest in developing joint projects.

THIRD: The development of this Framework Agreement of Cooperation will be carried out through specific agreements or addenda with reference to this present agreement.

FOURTH: In order to channel the relations, a follow-up commission is constituted, composed by a representative designated by EIIS and another representative designed by IYC.

FIFTH: The present Framework Agreement of Cooperation will have a duration of one year, extendable, except one of the parties denounces it, ninety days before the end of the date of the Agreement or any of its extensions.

SIXTH: The litigation matters that may arise from the interpretation and compliance of this Framework Agreement will be known and competent to the courts of Madrid.

In proof of the above and in accordance with all its clauses, both parties sign this Agreement, in exemplary duplicate and for a single purpose, at the date indicated in the heading.
